

HUD:

Reverse Mortgage Counseling provides seniors 62 and older comprehensive education and alternatives to FHA Reverse Mortgage; Foreclosure Avoidance Counseling is provided free of charge to residents of the State of Florida; NeighborWorks Eight Hour Curriculum Home Buyer Education Courses are provided to help educate buyers and provide eligibility for loan programs and home buying grants.

BK:

Consumers are provided a personally interactive credit counseling course which allows for a personal discuss of their financial situation as well as alternatives to bankruptcy and a plan to improve their financial situation; Personal Financial Management Instructional Courses education consumers on consumer protection laws, insurances, the use of credit, types of credit available, spending wisely and building and using a budget.

Other:


Free budgeting sessions and workshops are held daily; Free Financial Education Workshops cover: Credit, Good Debt, Bad Debts, Consumer Protection and more financial rescue options and alternatives. Intake Specialists determine eligibilty for the Florida Hardest Hit mortgage assistance program in partnership with FL Housing Finance Co.

DMP:

Credit Counseling and Debt Management Programs provide consumers overburdened with credit card debt, concessions to afford their monthly payments and pay off their debts within about five years time while preventing harm to their credit.


